



# MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN

# POORNIMA INSTITUTE OF ENGINNERING & TECHNOLOGY AND AIESEC IN JAIPUR

#### UNDER

#### POORNIMA STUDENT WORK ABROAD PROGRAM (SWAP)

AIESEC In Jaipur (AJ), an entity of AIESEC India & Poornima Institute of Engineering & Technology (PIET) an entity of Shanti Education Society here in after been mutually agreed upon the purpose of this agreement in accordance to the clauses given below.

Both PIET & AJ in connection with this agreement have agreed as follows:

- VALIDITY The validity of this agreement is from 1<sup>st</sup> October 2020 to 31<sup>st</sup> December 2023.
- **2. OBJECTIVE** The purpose of this agreement is to promote student exchange under Poornima Student Work Abroad Program (Poornima SWAP). Exchange Participant here shall mean:
- a. A student who goes to another country from India to gain work experience in their preferred field as an outgoing intern.

b. A student who is a citizen of any country other than India & coming to India to gain work Aperionce in their preferred field as an incoming intern.

#### 3. CATEGORIES OF OUTGOING INTERNSHIP:

a. OGV - The Outgoing Global Volunteer (OGV) program is the internship hosted by an AIESEC entity of any country but not India, under a project or a non-AIESEC organization e.g. NGO, organizations or schools. With OGV, AIESEC offers young people the opportunity to participate in international internships, experience leadership and partake in a global learning environment, thus create the international platform for every young member of India to develop their potential. The duration of this internship is 6 to 12 Weeks.

b. **OGT** - Outgoing Global Talent is an opportunity for a native of India to develop leadership qualities of self-awareness, solution orientation, empowering others and world citizenship while living a cross-cultural professional experience. In an outgoing Global Talent program, a young person works abroad to advance their goals. The duration of this internship is 12 to 72+ Weeks.

#### 4. CATEGORIES OF INCOMING INTERNSHIP:

a. IGV - The Incoming Global Volunteer (GV) program is the internship hosted by an AIESEC entity of India, under a project or a non-AIESEC organization e.g. NGO, organizations or schools. With iGV, AIESEC offers young people from other parts of the world the opportunity to participate in Indian internships, experience leadership and partake in Indian learning environment, thus create the international platform for every young member of the world to develop their potential. The duration of this internship is 6 to 12 Weeks.





### 5. PROCEDURE FOR OUTGOING INTERNSHIPS:

a. Poornima Institute Engineering & Technology has reserved a fund of INR 50000 per financial year to enable its students

for outgoing internships through AJ..

- b. The fund is available on first come first serve basis only. C. To facilitate maximum number of students for foreign internships, 50% of reimbursed in form of scholarship & rest 50% will be borne by student
- d. The administrative fee will be reimbursed after the completion of any of the outgoing internships within 30 days of return of an intern to India.
- e. The administrative fee will not be reimbursed after 30 days of return of an intern to India.
- f. An interested student must give his request for internship to the Head of the Department via form S-16.
- g. The Head of the Department will issue an NOC to AJ, certified by Registrar & Head of the Institution in attached Performa (annexure #1)
- h. The student will do all formalities with AJ & may proceed to any of the outgoing internships.
- i. After completion of internship, the intern student needs to submit form S-16 to the Head of the Department & a copy to AJ.
- j. After receiving the copy of form S-16, AJ will issue a completion certificate (annexure #

2) to the student.





k. Only after receiving the completion certificate PIET will reimburse the administrative fee to the student intern. 1. OGV - The administrative fee for OGV is INR 18000; m. OGT - The administrative fee for OGT is INR 21500 for internship duration of 3 months; n. OGT - The administrative fee for OGT is INR 21500 for internship duration of 6 months; 0. OGT - The administrative fee for OGT is INR 21500 for internship duration of more than 6 months.

# 6. PROCEDURE FOR INCOMING INTERNSHIPS:

- a. PIET & AJ after mutual discussions will raise various projects in all campuses of PIET to enable foreign interns to work & stay with PIET.
- b. PIET will facilitate incoming interns as per annexure #3.
- c. AJ will share bio data (attached as annexure #4) of all allocated interns to PIET atleast 15 days before the arrival at PIET
- d. PIET will be responsible for all its incoming interns from pickup & drop from & to the Jaipur International Airport or Jaipur Railway Station.
- e.PIET will provide an identification card to all incoming interns upon arrival provided that AJ share their bio data to PIET at least one week before their arrival.
- f. Upon arrival of incoming interns PIET will collect \$200 from each intern against accommodation & meal. g. \$50 out of \$200 will be kept by PIET as refundable security fee. \$50 will be refunded
- to the foreign intern upon receiving internship completion certificate from AJ with subsequent no dues formality to be completed at PIET Hostels.





#### 7. DELIVERABLES FROM AJ:

- a. AJ agree to set up a Campus Unit for the students for proactive learning within college premises by conducting Information & Cultural Preparation Seminars and Youth Empowerment Sessions. b. AJ will facilitate agreed number of exchange participants to & of PIET under above mentioned programs.
- b. AJ will share bio data (attached as annexure #4) of all allocated incoming interns to PIET at least 15 days before the arrival at PIET.
- d. AJ will provide to PIET, all reports, photographs & videos submitted by an
  incoming intern to AJ within 15 days of completion of internship.
- d. e. AJ will publicize about PIET Internships by sharing case studies of the exchange participants through AIESEC media network.
- e. f. AJ will support events at PIET by being a Youth Outreach Partner and AIESECers will need to show their presence in such events.

#### 8. DELIVERABLES FROM PIET:

 PIET will support AJ for its exchange programs - iGV, OGV, OGT & OGE. b. PIET will provide notice boards to display notice, posters and other promotional material of AJ.
