(hereinafter called 'the Publishers' which expression shall include the Publishers' administrators, assigns and successors in business as may be appropriate) of the other part

whereby it is mutually agreed as follows concerning a Work (consisting of a number of contributions) to be edited by the Editor and provisionally entitled

1. Rights and Copyright

(a) In consideration of the payments hereinafter mentioned and subject to the terms and conditions herein contained, the Editor hereby assigns to the Publishers the sole and exclusive right and licence to produce and publish and themselves further to license the production and publication of the Work in whole or in part in print and in electronic form in all languages for the legal term of copyright and all renewals and extensions thereof throughout the world.

- (b) The Work shall be delivered to the Publishers free of copyright charges.
- (c) The Editor will obtain from each Contributor to the Work a "Consent to Publish". For this purpose, the Publishers shall supply to the Editor the appropriate forms as attached to this Agreement, which shall be completed by the Contributor and submitted to the Publishers with the manuscript by the Editor.

2. Warranties and Indemnities

- (a) The Editor hereby warrants to the Publishers and their assignees and licensees that (he/she/they) has full power to make this Agreement and that the Work is in no way whatever a violation or infringement of any existing copyright or licence, or duty of confidentiality, or duty to respect to privacy, or any other right of any person or party whatsoever, that it contains nothing libelous, that all statements therein purporting to be facts are true and that any formula or instruction contained therein will not, if followed accurately, cause any injury, illness or damage to the user.
- (b) The Editor further warrants that the Work contains no obscene, or improper or blasphemous material nor is in any other way unlawful.
- (c) The Editor be solely responsible for Author's obtaining and paying for any third party permissions for the use in the Work of any material in which the copyright or any other intellectual property rights are owned by a third party, and when seeking such permissions the Author will obtain both print and electronic rights so that the materials can be used in both print and eBook formats of the published Work;
- (d) The Editor shall indemnify and keep the Publishers indemnified against all actions, suits, proceedings, claims, demands and costs (including any legal costs or expenses properly incurred and any compensation costs and disbursements paid by the Publishers on the advice of their legal advisers to compromise or settle any claim) occasioned to the Publishers in consequence of any breach of this warranty, or arising out of any claim alleging that the Work constitutes in any way a breach of this warranty. 3. Delivery of the Work

- (a) The Publishers will make available electronic templates, instructions according to which the Work has to be typed.
- (b) The complete manuscript will number no more than the number of pages as mentioned within the slabs in 4(f) including illustrations, tables and diagrams.
- (c) The Editor shall deliver to the Publishers, in one batch, the complete and original camera-ready manuscript with the exception of the title pages and the page numbers and accompanied by appropriate illustrative material and instructional aids, on or before **31st May 2024**.
- (d) By complete and original camera-ready manuscript is understood: Table of Contents except for the page numbers, Preface, (possible) Introduction, (possible) Acknowledgements, (possible) Committees and other materials for the preliminary pages; all accepted and submitted papers; the name(s) and affiliation(s) of editor(s), the title and subtitle of the book, choice of cover designs (STEM MONO 01 STEM MONO 46) chosen from: Cover Templates (routledge.com) and a blurb text.
- (e) The material must be delivered in electronic form (a separate file of each paper in WORD-) via email or online file-sharing: crcpress.wetransfer.com.
- (f) The Editor agrees to retain an additional copy of all material.
- (g) After the delivery of the manuscript the Editor will have one week time to inform the Publishers of any changes in the sequence of papers.
- (h) Delay in delivery of the complete manuscript can result in a delay in publication of the work, and/or may compromise the timely uploading of and providing access to the proceedings.
- (i) From the delivery date of the final and complete manuscript until the start of the conference the Editor will be available (or will arrange for a replacement) for proof reading or any other issues the Publishers might want to raise concerning the production of the book.
- (j) Should delivery of the manuscript be delayed by more than 12 (twelve) months the Publishers shall be at liberty to decline to publish the Work. If the Publishers so decline in writing this Agreement shall terminate subject to the following alternative provisos the choice of which shall be at the sole discretion of the Publishers:
 - (i) that the Editor shall not be at liberty to publish the Work elsewhere without having first offered the completed manuscript to the Publishers on the terms of this Agreement;

(ii) that the Editor shall refund any part of the advance already paid by the Publishers within 30 (thirty) days of a request in writing from the Publishers to do so.

4. Special Conditions

- (a) Acceptance of the manuscript is subject to review and approval by the Publishers.
- (b) The Editor/Institute shall pay a fee as per the selected slab as mentioned in 4(f) to one of the authorised distributor of the publisher as publication fee for the Work.
- (c) Payment to be made to the authorised distributor by the Editor/Institute, in the format described by the Publisher. The Editor/Institute is requested to make 30% of the total project cost as advance to the authorised distributor of the publisher. Followed by 20% payment of the total project cost at the time of submission of manuscript, 25% payment of the total project cost at the time of receiving 2nd proof readings, 25% payment of the total project cost at the time of submitting print copies of the proceeding. In case the complete manuscript goes beyond 700 pages, the institute has to pay INR 1,00,000 at the time of submission of the manuscript.
- (d) The Publisher will send **50 paperback** printed copies to the Editor after the Work is published.
- (e) The books will be available through our authorised distributor who will be responsible for delivery as mentioned under 4(d).
- (f) Any amendment of the fee will be agreed between the parties in writing where the number of pages are more or less than 300, as required by clause 3(b) of this Agreement.

- (g) No VAT will be added in case a GST number is available. If no GST number is available, the fee quoted are exclusive of possible fee charged by local customs office; these charges, if applicable, will be paid by the Editor/All prices quoted are VAT-free.
- (h) If the manuscript is delayed for more than 60 days from the mentioned delivery date in clause 3(c), the fee will be subjected to a revision and a new contract will have to be signed. In this case, this contract will be cancelled.

5. Publishers' Activities

- (a) The Work shall be published entirely at the cost and risk of the Publishers. All matters relating to the publication of the Work, including the paper, printing, design, binding and jacket or cover, e-book, the manner and extent of promotion and advertising, the number and distribution of free copies, the print number and price and terms of sales of the first or any subsequent edition of the Work shall be under the entire control of the Publishers.
- (b) The Publisher shall take responsibility and shall have the sole control for the warehousing and the distribution of the Work and shall promote and advertise and sell the Work in accordance with his normal sales arrangements.
- (c) The Publisher shall be entitled at his own discretion to present free of charge copies of the Work to periodicals, teachers and other persons through whom, in the opinion of the Publisher, publicity will be gained.
