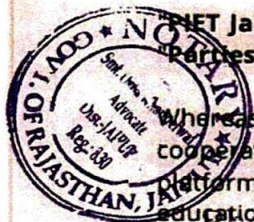




"PIET Jaipur" and "Zeetron Networks" are hereinafter referred to collectively as the "Parties" and individually as a "Party", regardless of the context.

B- Confidentiality



Without the prior written approval of the other party, and under no circumstances may such information be divested or disclosed to any other third party.

"Confidential Information" in this MoU refers to confidential and proprietary information relating to PIET Jaipur, and **Zeetron Networks**, including but not limited to: trade secrets, confidential information, technical processes, financials, software language codes, any research material, text transactions, and methods dealings with clients or clients and their employees and with PIET Jaipur and **Zeetron Networks** suppliers, employees, agents, distributors, clients and special trust with clients or clients Similar Information and Employees of a Confidential or Proprietary Nature Related to Confidential Relationships.

The parties agree that during and after the term of this MoU, the parties may use the Confidential Information only to perform their obligations and/or exercise their rights under this MoU and shall not disclose any Confidential Information to any third party without the consent of the other party prior written consent.

C: Non-exclusivity

The relationship between the parties under this MoU shall be non-exclusive and the parties, including their affiliates, subsidiaries and divisions, are free to seek other cooperation in any form.



D: Terms and Conditions

- **Zeetron Networks** and **PIET Jaipur** have partnered to provide Summer Internship, In-House training, Workshop, Seminars for students of the PIET Jaipur.
- **Zeetron Networks** will provide PIET Jaipur students with Summer Internship Program. Internship opportunities are solely based on the student's performance in an interview conducted by Zeetron Networks.
- **PIET Jaipur** will provide laboratory infrastructure including a projector with screen, Internet access without restrictions (firewall) - Wifi preferred, Computer Hardware, etc.
- All software required for the internship program will be arranged by **Zeetron Networks** at its own expense and will remain the exclusive property of Zeetron Networks and a certificate will be awarded to all students who successfully complete the training and seminars.
- This **MoU** is valid for Summer Internship Program, In-house training, workshop and seminar from March 2023 to March 2026 and may be renewed upon mutual agreement.
- Either party may terminate this MoU by giving the other party three month's prior written notice.
- The terms of the MoU may be modified at any time with the written consent of both parties.
- Unless otherwise agreed by the parties, the amendment, termination, and expiration of this MoU shall not affect the terms of the activities in progress at the time of notification of the amendment, termination, and expiration.
- **PIET Jaipur** agreed not to employ engineers employed by **Zeetron Networks**.
- The parties agree that the existence and terms of this MoU are confidential and shall not be disclosed to any third party.
- **Zeetron Networks** will provide the training material to students in the form of software.
